Your rights to cast a ballot in the May 20, 2003 Special Election has been challenged under the provisions of RCW 29.10.125 – 29.10.140, by Cindy Lee Broughton on the grounds that neither of you reside at the address where you are registered to vote, 33902 State Route 2, Sultan.

The Canvassing Board will convene and rule on this action:

Thursday, May 29, 2003 – 9:00 AM

Auditor's Office, 1st Floor, Administration Building, 3000 Rockefeller Ave, Everett WA

Both the challenged voters and the challenger must either appear in person to present evidence or submit an affidavit to rebut or support the challenge. The challenging party must prove to the Canvassing Board by clear and convincing evidence that the ballots cast in the May 20, 2003 Special Election are improper. The decision of the Canvassing Board shall be final.

If your current registration address is outdated you may update your address by completing and mailing the enclosed voter registration form. However, changing your address may not affect the final decision of the Canvassing Board to count or discount your ballots.
